

## State Board of Nursing Licensure Eligibility

Disclosure

Many professions in the U.S., such as schoolteachers, attorneys, physicians, pilots, and nurses, require a license as a condition of practicing a chosen profession. The purpose of professional licenses is to protect the public from harm by setting minimal qualifications and competencies for safe entry-level practitioners. Only a licensed nurse is authorized to use certain titles (i.e., registered nurses [RNs], licensed practical/vocational nurses [LPN/ VNs], advanced practice registered nurses [APRNs], etc.) or to represent themself as a licensed nurse.

Said licenses are issued on a state-by-state basis, as such, the requirement for licensure may be varied by issuing body. The National Council of State Boards of Nursing, Inc. (NCSBN) has developed a comprehensive list of state-by-state requirements, which can be found by visiting: https://www.ncsbn.org/14730.htm.

Review of state-by-state licensure eligibility based on Pennsylvania Institute of Technology's curriculum is completed on both an ongoing and as-needed basis.
